## WHAT DOES QUALITAS INSURANCE COMPANY DO WITH YOUR PERSONAL INFORMATION?

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>■ Social Security number and [income]</li> <li>■ [account balances] and [payment history]</li> <li>■ [credit history] and [credit scores]</li> </ul>	
<b>How?</b>	<p>All financial companies need to share consumers' and customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their consumers' and customers' personal information; the reasons Qualitas Insurance Company chooses to share; and whether you can limit this sharing.</p>

What we do	
How does Qualitas Insurance Company protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We have implemented reasonable administrative, technical, and organizational measures designed to protect your information in line with the Safeguards Rule.
How does Qualitas Insurance Company collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>■ [open an account] or [deposit money]</li> <li>■ [pay your bills] or [apply for a loan]</li> <li>■ [use your credit or debit card]</li> </ul> <p>[We also collect your personal information from other companies.]</p> <p><b>OR</b></p> <p>[We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.]</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>■ sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>■ affiliates from using your information to market to you</li> <li>■ sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	<p>[Your choices will apply to everyone on your account.]</p> <p><b>OR</b></p> <p>[Your choices will apply to everyone on your account—unless you tell us otherwise.]</p>
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ <i>[affiliate information]</i></li> </ul>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ <i>[nonaffiliate information]</i></li> </ul>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>■ <i>[joint marketing information]</i></li> </ul>
Other important information	
<p>If you are a resident of California, we will ask for consent before sharing your personal information with a non-affiliated third party. You also have the right to opt-out of personal information sharing with affiliates.</p>
